Session 2017-18


- The students approached their teachers and told about the problem of seating in their vacant period.



## Session 2019-20


- With the increasing awareness about various competitions for jobs and admissions etc., the students met their teachers with the problem of access of online material in the library.



Session 2021-22

- A case of representation of the students regarding problem of drinking water in college was reported to Cell. A meeting of the Cell was held on 15.10.2021. In view of the sensitivity of the issue, the matter was taken up with serious consideration. In view of uprooting the problem, it has been decided that a centralized RO and Chilling plant would be installed near library/PG block. The Management and the Principal instantly acknowledged the problem and installed RO and chilling plant on the roof of PG Block.
- A case of representation from boy students regarding common room or any place for taking lunch was reported to Cell. A meeting of the Cell was held on 22.10.2021.
